

What is the SBAC Test?

The SBAC test is a high stakes, high failure rate test That will be required In Washington state In Spring 2015 for All 3rd Grade, 4th Grade, 5th Grade, 6th Grade, 7th Grade, 8th Grade & 11th Grade students.



Over 500,000 students in Washington state will be Required to take the SBAC test in Spring 2015.




While only 14% of Washington students were "below grade level" on the 2013 National Assessment of Educational Progress test, 61% will be labeled as failures by the SBAC test!


Even the former "WASL" test only labeled One out of three students as failures.



The SBAC Shell Game...


Will your child get easy questions...

SBAC is also an "adaptive" test. This means students who get the first few questions right are given a much harder test than those who get them wrong.




The SBAC test uses more than 40,000 questions. A test would be more valid and reliable if it used 40 well researched and fair questions than 40,000 poorly researched and unfair questions.





STEP THREE: Be aware that school administrators Have been given a detailed manual instructing them on how to try to change your mind about opting out!

You will likely be discouraged from opting out by your child's teacher, principal and other school administrators. You will be told that your child will receive a score of "zero" which will harm your child and your child's school. Our advice is to let teachers and administrators know that the SBAC test itself is far more harmful to your child and your child's school that opting your child out of the test. Feel free to print out and share our one page flier on the drawbacks of the SBAC test with teachers and administrators. You may also be told that your child may not receive a diploma if they do not take the SBAC test. This is not true. As long as your child completes the required courses and credits, they will be given a diploma. The SBAC test is not needed to graduate.

Our Opt Out form contains 4 important pages of advice including likely tactics, state regulations, state laws and Supreme Court rulings that explain your rights As a parent to control the education of your children!

STEP FOUR: Fill Out Page 1 of the SBAC Opt Out Form & Turn it in to the front office of your child's school

Do parents have any civil rights regarding the education of their child?

The U.S. Supreme Court has long held that the 14th amendment to the U.S.


Constitution guaranteed certain fundamental rights which cannot be removed without due process of law. One of those fundamental rights is the right of parents to direct the upbringing and education of their children. In its 1923 decision in Meyer v. Nebraska, the U.S. Supreme Court "held that the 'liberty' protected by the Due Process Clause includes the right of parents to 'establish a home and bring up children' and 'to control the education of their own." (Quoted from the 2000 U.S. Supreme Court ruling in Troxel v. Granville.). The Court concluded in Troxel v. Granville: In light of this extensive precedent, it cannot now be doubted that the Due Process Clause of the Fourteenth Amendment protects the fundamental right of parents to make decisions concerning the care, custody, and control of their children. (Troxel, 2000)

Your school principal may ask to meet with you.
While you are not required to meet with them,
Taking a few minutes to share your concerns about
The SBAC test may help gain their cooperation.
